TERMS AND CONDITIONS

1. The term of this contract is for an indefinite period of time until terminated (upon five (5) days notice) by the client, "*Pet Buddies*" Pet Sitting Service LLC, or its contractor. At this time, all advance payments shall be returned, minus \$15 for administrative fees.
2. The fee for services will be based on the printed, current standard fees in effect at the time services are rendered.
3. "Pet Buddies" Pet Sitting Service LLC is authorized to perform care and services as outlined on this contract and authorized by the signature below to seek emergency veterinary care with release from all liabilities related to transportation, treatment and expense. Should the specified veterinarian be unavailable, "Pet Buddies" Pet Sitting Service LLC is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. The customer agrees to reimburse "Pet Buddies" Pet Sitting Service LLC for expenses incurred, plus any additional fees for attending to this need or

any expense incurred for any other home/food/supplies needed. Additional time spent by "Pet Buddies" Pet Sitting Service LLC or its contractor in requesting medical care or attention will be billed to the client at the hourly rate in effect at the time the services are rendered.

4. In the event of inclement weather or natural disaster, the pet sitter is entrusted to use their best judgment in caring for the pet(s) and home. "Pet Buddies" Pet Sitting Service LLC will be held harmless for consequences related to such decisions.
5. "Pet Buddies" Pet Sitting Service LLC agrees to provide the services stated in this contract in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives and relinquishes any and all claims against said "Pet Buddies" Pet Sitting Service LLC except those arising from negligence or willful misconduct on the part of the pet sitter.
6. The client understands this contract also serves as an invoice and takes full responsibility for prompt payment of fees upon completion of services contracted. A finance charge of 1 1/2% per month will be added to unpaid balances after thirty (30) days. A handling fee (\$25) will be charged on all returned checks. A one half deposit is required on lengthy assignments and first time clients or clients with a history of late payments will be required to pay in advance before services are rendered. In the event it is necessary to initiate collection proceedings on the account, the client will be responsible for all attorney's fees and costs of collection.
7. In the event of personal emergency or illness of the pet sitter, the client authorizes "Pet Buddies" Pet Sitting Service LLC to arrange for another qualified pet sitter to fulfill responsibilities as set forth on this contract. The client will be notified in such a case.
8. The client assures "Pet Buddies" Pet Sitting Service LLC that all pets are currently vaccinated. Should the pet sitter be bitten, or otherwise exposed to any disease or ailment received from the client's animal which has not been properly and currently vaccinated, it will be the client's responsibility to pay all costs and damages incurred by the victim. The client has warned "Pet Buddies" Pet Sitting Service LLC or its contractor of any hazards concerning the premises and/or

pet(s) currently or in the past, that could affect the performance of the agreed upon services or cause harm to the pet sitter.

9. "Pet Buddies" Pet Sitting Service LLC reserves the right to terminate this contract at any time before or during its term if "Pet Buddies" Pet Sitting Service LLC in its sole discretion, determines the client's pet poses a danger to the health and safety of the pet sitter. If concerns prohibit the pet sitter from caring for the pet, the client authorizes the pet to be placed in a kennel, with all charges from there to be charged to the client.
10. The client authorizes this signed contract to be valid approval for future services of any purpose provided by this contract permitting "Pet Buddies" Pet Sitting Service LLC to accept telephone reservations for service and enter the premises without additional signed contracts or written authorization.
11. The client will allow "Pet Buddies" Pet Sitting Service LLC and its contractor to enter the residence when service has been requested and beyond the scheduled time if the client fails to notify "Pet Buddies" Pet Sitting Service LLC upon returning home. Should the client return home prior to the previously arranged time, the pet sitter must be notified in order to avoid being billed for a visit that would otherwise be unnecessary.
12. The client agrees to provide properly working keys needed to access his/her home. The keys will be retained by "Pet Buddies" Pet Sitting Service LLC or its contractor for future pet sitting, unless otherwise stated. The client further agrees to pay the current key pick-up and drop-off fees in effect if he/she does not wish for "Pet Buddies" Pet Sitting Service LLC to retain the client's key(s) to the home. In the event that "Pet Buddies" Pet Sitting Service LLC is required to employ a locksmith to gain entry to the client's premises due to a malfunctioning of the lock or failure of the client to leave a key, it shall be the responsibility of the client to reimburse for all the costs incurred. The client expressly gives "Pet Buddies" Pet Sitting Service LLC the authority to employ a locksmith on the client's behalf in the event of the aforementioned occurrences.
